RELATIVE CAREGIVER CERTIFICATION ROLLOUT!

On January 12th, 2026, DCFS is rolling out the new Relative Caregiver Certification Process. This process is pertinent only to our **unlicensed relatives**. If you are an unlicensed relative, you can expect that your licensing worker and caseworker will be providing details about how to become certified. DCFS and The Baby Fold are encouraging all of our unlicensed relatives to become certified. Intentional changes have been made to make the process of certification as simple and streamlined as possible.

WHY THE BABY FOLD MAY CALL YOU ABOUT PLACEMENT



Illinois DCFS is required by policy to make “diligent efforts” to find a safe placement for children and youth who need immediate care. This means DCFS or a contracted agency (e.g., The Baby Fold) must contact **all possible placement options**, including relatives, fictive kin, and **all licensed foster homes**, even if a foster home has previously shared that they are not currently able or willing to accept a placement.

Emergency placements are temporary and are used to help children stabilize during a crisis or when first entering care, while a longer-term plan is being identified. Because DCFS must document that every option was explored, foster parents may receive a call from The Baby Fold even when the agency understands they are not available. **Receiving a call does not mean there is an expectation to accept a placement—only that the agency is meeting its required diligent-effort standards.**



FOSTER PARENT RIGHTS & RESPONSIBILITIES #1

Foster Parents' Rights:

#1. The right to be treated with dignity, respect, and consideration as a professional member of the child welfare team.

Foster Parents' Responsibilities:

#1. The responsibility to openly communicate and share information about the child with other members of the child welfare team.

TBRI

Trust-Based Relational Intervention is an attachment-based, trauma-informed intervention that is designed to meet the complex needs of vulnerable children. TBRI uses Empowering Principles to address physical needs, Connecting Principles to meet attachment needs, and Correcting Principles to disarm fear-based behaviors.
