



Hammitt School's Meal Outreach Summer 2024

We are pleased to inform you that The Baby Fold and Hammitt Schools will be implementing the National School Lunch, School Breakfast, and Summer Food Service Programs called the Community Eligibility Provision (CEP) for Summer 2024 and school year 2024-2025.

What does that mean for you?

All enrolled students of Hammitt schools are eligible to receive a nutritious breakfast and lunch at school at no charge to your household. No further action is required of you. Your child(ren) will be able to participate in these meal programs without having to pay a fee or submit an application.

Meal Information

In the serverys, signs are posted along each serving line that lists what comes with each meal to assist students in making their selections.

Breakfast

Served in Servery and eaten in their classrooms. (Oglesby West, Willow Front, and Willow Side) Breakfast is from 8:15 -8:50 am. All breakfasts come with the following:

- Main Course
- Protein
- Fruit
- Fruit Juice (4 oz)
- Milk (8 oz)

Offer vs Serve- Students must choose 3 items and one must be a fruit or fruit juice. Straight Serve- Students must take the entire meal including milk

Lunch

Options change daily, see the monthly menu for choices offered. On the Willow St campus lunch is served in the classroom from 11:45- 12:15.

On the 612 Oglesby campus meals are served in the West servery beginning at 11:50-12:20

All options offered qualify as a free meal and come with the following components unless otherwise noted:

- 1 Entrée
- 2 Vegetables
- 1 Fruit
- Milk (8 oz)

Offer vs Serve- Students must choose 3 items and one must be a fruit or vegetable.

Straight Serve- Students must take the entire meal including milk. Milk is offered with every meal.
